



The Parties are independent professionals. This certificate shall not in any way constitute a work agreement, deed of partnership, simple partnership or joint venture agreement.



The Agent acts on his own responsibility and is not entitled to any rights or claims based on legal grounds other than present in this certificate and bestowed onto him by the Agency Agreement.


